

GLOSSARY

Value Added (VA) = Value Added is added value that is successfully obtained by a company from the sales profits they generate.

Capital Employed Efficiency (CEE) = Capital employed efficiency is a measurement model that focuses on physical assets where Capital employed efficiency measures how efficiently a company uses its physical assets to create Value Added.

Human Capital Efficiency (HCE) = Human Capital Efficiency focuses on human resources where this measurement shows how efficiently a company utilizes its human resources to generate added value.

Structural Capital Efficiency (SCE) = Structural capital efficiency is the dependent variable with human resources with measurements related to copyright, business culture, patents, production processes and all things that can expedite the process of generating value added.

Relational Capital Efficiency (RCE) = Relational capital efficiency is used to measure how much influence the relationship has with external entities such as suppliers, distributors, customers and business partners in order to expedite the process of generating added value.

Earning Per Share (EPS) = Earning per Share is the ratio obtained from the company's net profit divided by the number of company shares outstanding in the market.

Price Book Value (PBV) = Price book value is the ratio used to measure whether a stock is said to be cheap or expensive for investors.
